



**ADDENDUM TO MEMORANDUM OF AGREEMENT  
ENTERED INTO BY AND BETWEEN**

**SEDIBENG DISTRICT MUNICIPALITY** herein represented by  
**STANLEY KHANYILE** in his capacity as the **Municipal Manager**, duly authorised thereto,  
(hereinafter referred to as the “**Sedibeng District Municipality**”);

**AND**

**MESSRS VAAL TRIANGLE FIRE SERVICES (Pty) Ltd** , a company duly registered in  
accordance with South African company law, with Registration Number 1962/03463/07 , herein  
represented by **NEIL VILJOEN** in his capacity as **Managing Director** duly authorised thereto,  
(hereinafter referred to as the “**Vaal Triangle Fire Services**”).

**1. BASIS OF THE ADDENDUM**

**WHEREAS** the Sedibeng District Municipality and the Vaal Triangle Fire Services entered into a memorandum of agreement for the Supply, Service and Repair of Fire Extinguishers for Sedibeng District Municipality under tender number 8/2/2/1/2016, with a commencement date of 1 August 2016 and a termination date of 31 July 2019, (the main agreement);


**AND WHEREAS** the Parties enter into this Addendum, which Addendum shall together with the main agreement and Annexures thereto; as amended herein, constitute the whole Agreement between the Parties.


**NOW, THEREFORE**, in consideration of the mutual provisions set forth in this Addendum and in the main agreement, the parties to this Addendum agree as follows:

*S-k*

1. Notwithstanding the date of signing of this agreement, the agreement is extended with a period of four (4) months commencing from 1 October 2019 until the 31 January 2020 in order to allow finalization of the Supply Chain Management process for the appointment of the new Service Provider.
2. Notwithstanding the extension of this agreement as per clause 1 above, Sedibeng District municipality shall have the right to terminate this agreement upon the appointment of the new Service Provider
3. The contents of this Addendum are the only amendments of which shall remain valid and binding on the Parties until the agreement terminates.
4. Excluding the amendments contained herein, the stipulations of the main agreement shall remain applicable to the parties and shall not be considered a novation of the main agreement.
