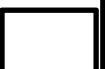

## 1. PURPOSE

This bid seeks to invite proposals from suitably qualified service providers for the supply of primary reference gas mixture (PRGM) of 5kg cylinder containing a mixture of sulphur dioxide (SO<sub>2</sub>) in nitrogen (N<sub>2</sub>) and a 5kg cylinder containing a mixture of Nitrogen Oxide (NO) in Nitrogen (N<sub>2</sub>) as well as stainless steel regulators and bullnose. The gases are used to validate and/or calibrate analytical methods or the calibration of measurement systems used to determine the mole fraction of SO<sub>2</sub> in N<sub>2</sub>, and a mole fraction of NO in N<sub>2</sub>.

## 2. INTRODUCTION

In terms of the Air Quality Act (Act 39 of 2004), Metropolitan and District Municipalities are charged with monitoring ambient concentrations of priority pollutants as set out in the act. Sedibeng District Municipality is currently operating and maintaining two (2) ambient air quality monitoring stations. The data collected from these monitoring stations plays a key role in making informed decisions about the measures required to protect the health & safety of living entities and protection of the environment itself. Reliable measurements underpinned by accurate measurement standards (i.e., certified reference materials) are indispensable for the verification that products and services comply with the legislation that exists to protect our environment. To confidently provide accurate, reliable, and comparable measurement results, analytical testing laboratories are required to use various measurement standards, known as reference materials (RMs), for quality control, accuracy assessment, to establish measurement traceability and to demonstrate continued laboratory competence (RMs used in PTs). Use of these materials is prescribed in the ISO 17025 standard for the competence of testing and calibration laboratories.



### 3. SCOPE OF WORK

The following Gases must be analysed from an accredited metrology institution in South Africa for the preparation of calibration gas mixtures using a gravimetric method. This is done for the purpose of compliance with national norms and standards of air quality monitoring in South Africa and international measurement standards to conform with the ISO/IEC 17025 and ISO 6142 which requires reference material used for calibration of measurement equipment to be traceable to SI Units.

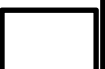
